The present situation requests not only the development of proper emergency practices, policies and procedures, but also **to make them certified by accredited qualified third parties.**

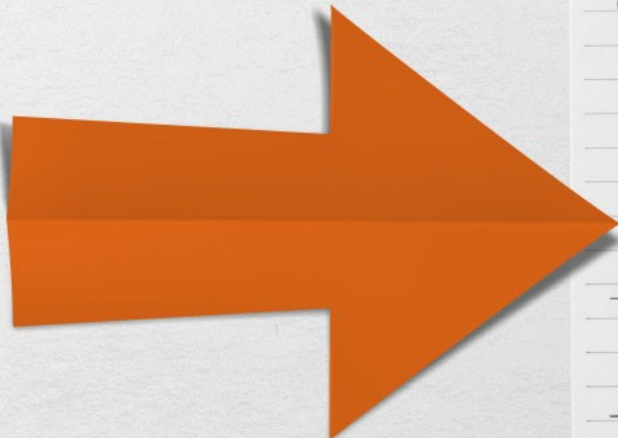
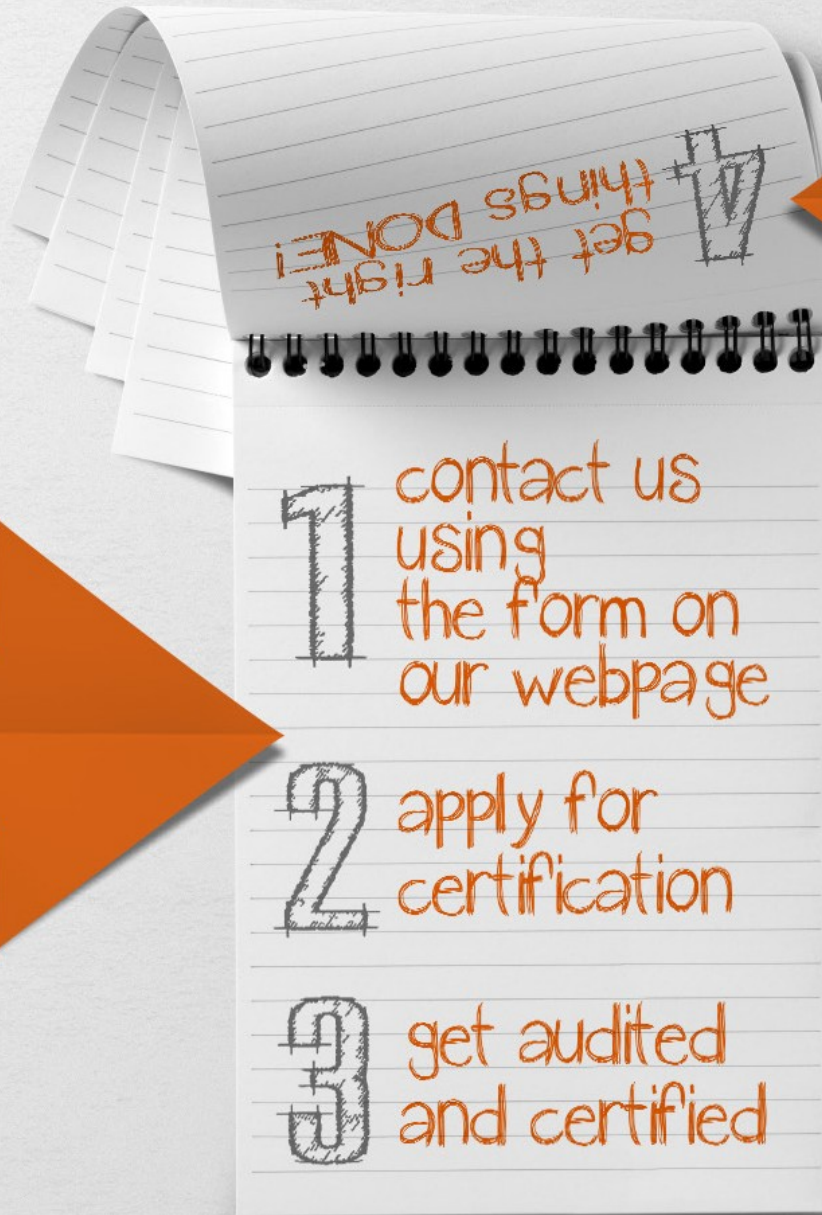

- **EIFEC ES2001.06:HBV/SSP - Compliance Management Systems for Sanitization Service Providers (SSP-CMS)**, reserved to professional Sanitization Service Providers

**Both Standards** are provided also in a **simplified version specially designed for Micro, Small and Medium Enterprises (MSMEs)**, so to apply in full our philosophy: **“Compliance for all”**

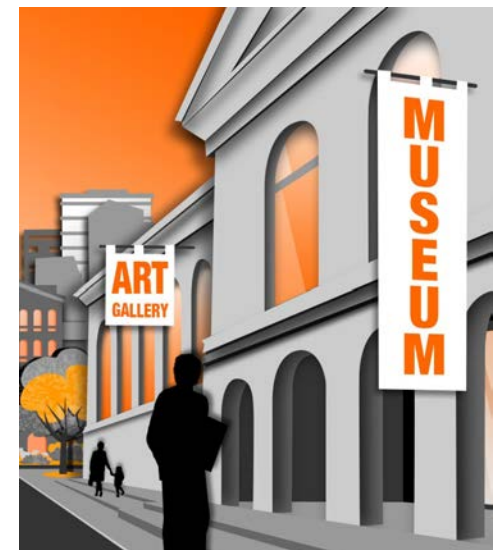

- **Auditors and advisory organizations**



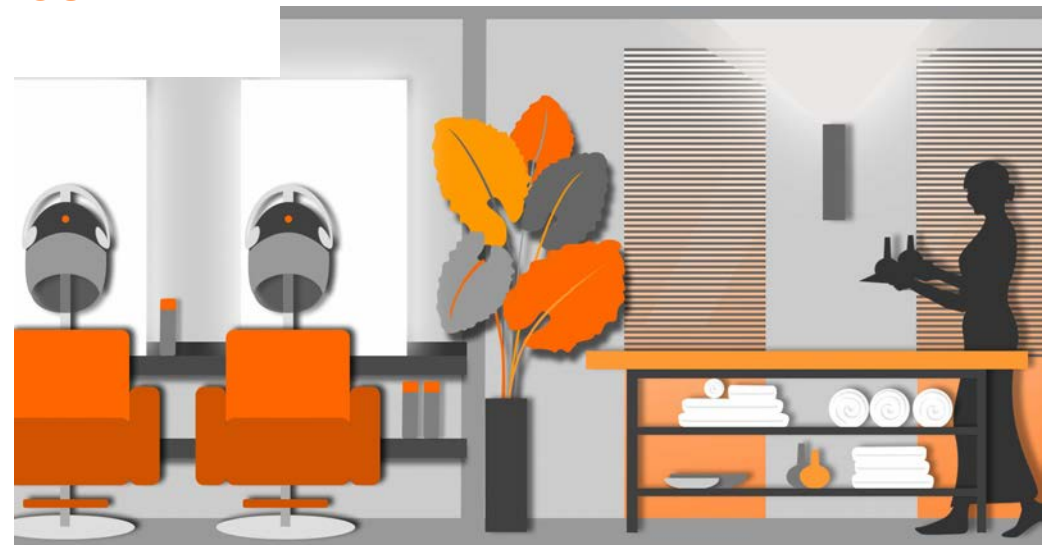
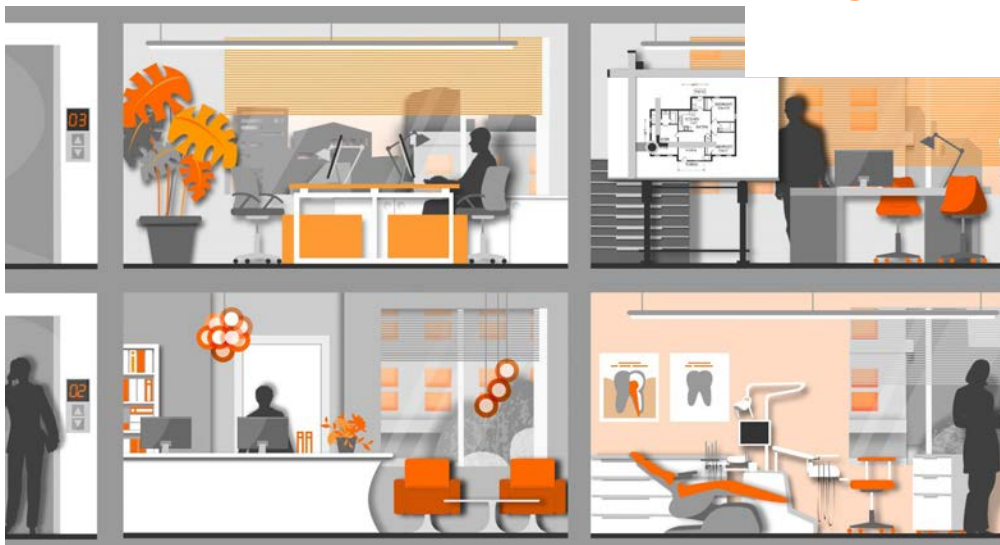
